- Send up to 10 images per show - SLIDES or high quality 8.5" X11" PRINTS of each image. Label slides and printouts clearly with artist's name, title of work, dimensions (framed size), medium, and date of artwork and please indicate TOP of slides. Send a SUBMISSION LIST including the artist's name, title of work, dimensions (framed size), medium and date of artwork. Number images to reference inventory list.
Optional: Submit high quality slides or high resolution digital images (300 dpi) for press/ promotional use.
- Please include a self-addressed, stamped envelope or your slides/prints will not be returned. Please ensure proper postage or pick them up at the GCCA office.
- No entry fee. **GCCA membership is required to exhibit.** Membership forms are available at www.greenearts.org.

- **Accepted work must be ready to display.** Two-dimensional artwork must be suitably framed and ready for hanging. **HANGING WIRE required.** Please check with us on availability of pedestals for three-dimensional works. Any special hanging or displaying arrangements must be made in advance with the Visual Arts Director.
- Commission: 70% artists and 30% GCCA.

- Mail or hand deliver exhibit application and all relevant materials by the application deadline to Visual Arts Director, GCCA, 398 Main Street, POB 463, Catskill, NY 12414.
- * **SOLO EXHIBITION PROPOSAL** - Submit 10-20 images with a SUBMISSION LIST on SLIDES or high quality 8.5" X11" PRINTS. Include a resume and artist statement. Please include a self-addressed, stamped envelope or your slides/prints will not be returned. Please ensure proper postage or pick them up at the GCCA office.
- ****CURATORIAL PROPOSAL** - Submit a detailed description of your proposal. Include examples of artwork, resume and artist statement. If Curatorial Proposal is accepted, you will be expected to contact potential artists for submissions as well as co-jury and co-curate the exhibition.
